**Embedded viewers** >> Upon inserting the Publisher Bundle™ compact disc into your CD-ROM drive, the viewing environment will automatically open and list the contents of the bundle. You'll require no additional software to thoroughly review all of the transcripts and exhibits.

**Review transcripts and exhibits** >> Simply click on a transcript (left window) or an exhibit (right window) to open, modify on-screen appearances, or print. The Hyperlinked Word Index embedded with each transcript and OCR'd document facilitates quick and accurate word searches.

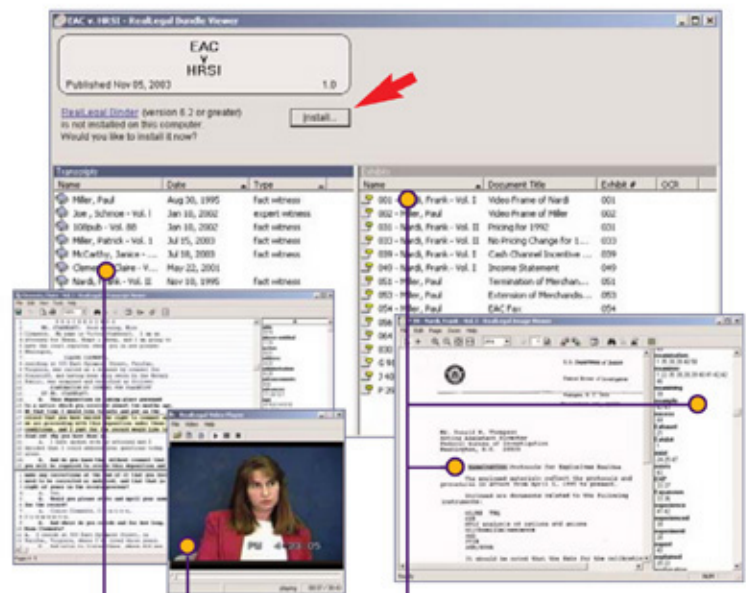
**Hyperlinks** >> Your reporter can establish hyperlinks between exhibits and where they are marked or referenced in the transcripts. These links remain active if the Publisher Bundle is imported into RealLegal Binder™.

**Easy RealLegal Binder import** >> The entire contents can be loaded into an existing RealLegal Binder project, or into a

demo version of the software (see **arrow**). Once imported into RealLegal Binder, you can utilize complete annotating, digesting, searching and reporting tools.

**Bundles grow as your case grows** >> As your case progresses, and additional depositions are held, you can request updated Publisher Bundle CDs. Your first Publisher Bundle may contain four days worth of discovery, while the third Publisher Bundle may contain three weeks worth of transcripts and exhibits. The compact bundle is a software-independent way to transport and archive case materials.

**Internet delivery** >> Your court reporter may offer a private and secure RealLegal iBinder™ Web repository for instant access to the contents of the Publisher Bundle. The discovery can then be easily shared with co-counsel or imported into RealLegal Binder.



Select an exhibit to view within the included RealLegal Image Viewer. Select a word from the index and its occurrence is highlighted in the document.

Select an E-Transcript to view. If it has been synched with video, the RealLegal Video Player will launch. Corresponding text in the transcript is highlighted as it is spoken on the video.
